Amazon.com Inc is in talks with Reliance Industries Ltd's retail unit to buy a stake in India's biggest brick-and-mortar retailer, two sources with knowledge of the talks told Reuters on Friday.

Amazon's massive online presence could help bolster Reliance's consumer and private labels business. More importantly, a potential partnership will help the duo counter Walmart, which last year' invested \$16 billion in Flipkart, in their battle for a bigger share of India's fastgrowing e-commerce market.

Amazon had made the proposal to Reliance for the partnership, but it was not clear whether a deal would materialise, said one of the sources. The second source said
