

# Consider junking BMC project, HC tells state govt

### 'Plan only on paper for the past 30 years'

THE High Court on Monday directed the state government to consider discarding the Bangalore-Mysore Infrastructure Corridor (BMIC) project, which has remained only on paper over the past 30 years.

"The project proponents are collecting huge tolls by constructing peripheral roads and toll plazas. They are sitting on a huge land bank, but without its proper use as the expressway has not yet been constructed, and there is no sign of it being constructed in future. Therefore, we direct the state government to re-look the project and take appropriate steps in this regard", said a division bench of Justice D K Singh and Justice Venkatesh Naik T.

The court made these remarks while dismissing the petition filed by Chandrika, a resident of Benson Town in Bengaluru, seeking directions to NICE Ltd and the state to provide compensation, as the petition suppressed the fact that she obtained Rs 51.36 lakh compensation in 2007 by executing an indemnity bond for full and final settlement of compensation for acquisition of 3 acres and 23 guntas near Kengeri in Bengaluru.

The project and its planning, as delineated in the Project Technical Report (PTR), has remained only on paper, even after 30 years, for various reasons... It is informed that out of

111 km of BMIC, only 1 km has been constructed by Nandi Infrastructure Corridor Enterprise (NICE). It has constructed 47 km of peripheral roads from which it collects toll tax to its profit. But the ambitious project of such a public interest to decongest the city and to develop a new satellite township has remained only on paper. Not even a single township has been developed in the last 25 years. The result is that, today, it is difficult to travel on the roads of Bengaluru, and mobility has come to a standstill, the court noted.

No purpose would be served by keeping the project alive when, in more than 25 years, only one kilometre has been constructed. It would be in the interest of the city, citizens, environment and the future, to re-look the project and take appropriate action for a fresh and new project, discarding the old one, the court said.

"The population of the city is more than 1.4 crore. It takes hours to travel a small distance in the city. The infrastructure facilities are crumbling down. The environment is badly affected. The state government, therefore, must take necessary decisions for fresh planning by discarding the Framework Agreement at the earliest to ameliorate the living conditions of the city. We hope that an informed decision will be taken in this regard at the earliest," the high court bench observed.



# Family says no to gold stash; ASI, Patil say it's treasure

THE developments after a family in Lakkundi carried a stash of gold ornaments buried under the earth on their land took a new twist on Monday. The family who earlier staked claim on the gold now says they do not want it. State Archaeological Survey of India Director Dr R Shejshwar visited Lakkundi on Monday and confirmed that the find is a treasure.

However, the change of mind reportedly took place after some seniors of the village told the Ritti family that taking pos-

session of a treasure is a sin. Several villagers told the family that their land where the treasure was found is located behind the Lakshmi temple, hence, they should donate the land to the temple. Heeding this, the family has now requested the district administration to help them get another house.

Iraanna Bandi, a septuagenarian, said, "We have seen many people who had taken such treasures suffering losses. Call it superstition, karma or whatever, but we have seen some families who suffered after taking gold dug up from

their lands. Hence, we have suggested to the Ritti family to ask the government for help in getting a new house, and we will also help them."

Both district in-charge minister HK Patil and state ASI Director Dr R Shejshwar said the gold found by the family was a treasure.

They said they respect the honesty of the family and the latter will be given suitable reward according to the law.

On Sunday, an ASI official from Dharwad said that the golden ornaments cannot be classified as a treasure but changed his statement on Mon-

day, saying that he was confused.

Patil said any valuable asset found under the earth is a treasure, and it is government property.

Former minister and Lakkundi MLA CC Patil, who visited the village on Monday, said, "ASI officials should not give confusing statements. I congratulate the Ritti family for their honesty in handing over the gold to the district administration."

Gadag DC CN Sridhar said, "The family has shown their honesty and we will act according to the law."

## E-auction of excise licences postponed on HC directive

Bengaluru: The state government has postponed the e-auction of excise licences following the directions of the High Court of Karnataka, Dharwad Bench. In an official statement, the Additional Commissioner of Excise department said that as per an earlier notification, the live bidding of excise licences was scheduled to be held through the MSTC Portal (https://www.mstccommerce.com) from January 13 to 20. Following the directions of the High Court of Karnataka, Dharwad Bench in the writ petition (No.:110093/2025) dated December 26, 2025, the e-auction process is hereby postponed till further orders. The revised schedule of e-auction dates will be intimated later, the statement added. ## Battling illnesses, activist seeks nod for euthanasia

ACTIVIST HB Karibasamma has urged the state government to implement and communicate a clear legal process and issue guidelines for euthanasia at the earliest.

The 86-year-old woman fighting for this cause for over a decade, stated that the right to live with dignity must also include the right to die with dignity in cases of unbearable suffering. She said the government has failed to take the legal framework on euthanasia to the public, even years after recognising it.

Karibasamma stressed that euthanasia procedures must be made available in government hospitals, which she described as the only accessible institutions for the poor. She pointed out that thousands of poor and elderly people, lacking financial and social support, continue to suffer from multiple ailments, spending their final

years in extreme pain and helplessness, often confined to their beds and dependent on others even for basic needs. People remain confused about where to apply for euthanasia and which hospitals to approach, leading many elderly persons to die in agony without clarity or assistance, she said.

She appealed to the state government to issue clear guidelines and not "invite the curse of the suffering elderly" by delaying action.

Sharing her personal circumstances, Karibasamma said she is battling several illnesses and no longer wishes to continue a life of constant physical struggle. She said she has already submitted medical reports and sought permission for euthanasia from the Davanagere Deputy Commissioner, the local court, the Governor, and both the State and Central governments. She said that if permission is denied, she would end her life on behalf of crores of elderly people.
