

### 3 killed as tourist bus crashes into oil tanker in Udipi

Udipi: Three persons were killed and several others injured after a tourist bus ramed into a stationary petroleum tanker and a lorry on NH-66 near Maravanthe-Trasi on Tuesday afternoon. Police identified the deceased as spare driver Raghu alias Umesh (34), cleaner Ranganath, and cook Hemanth. Three injured students are undergoing surgeries and are said to be out of danger. The bus was carrying final-year B.Com students of University Srimad Rambhapuri College of Arts & Commerce along with teachers, staff, and crew members. They had left on April 26 for a tour.

# KRRS demands 20-fold increase in NDRF compensation

Farmers want relief for crop damaged in Holehonnur, Koodligere and other parts of dist due to heavy rains that lashed S'mogga on April 26

MEMBERS of the Karnataka Rajya Raitha Sangha and Hsiru Sene staged a protest in front of DC's office here on Wednesday and submitted a memorandum to the deputy commissioner demanding compensation to crops that were damaged in Holehonnur, Koodligere and others due to hailstorm and rains accompanied by thunderstorm on April 26. The farmers demanded an increase of the National Disaster Relief Fund (NDRF) by at least 20 times. They said, in the memorandum, that many houses were damaged due to rains that

lashed the district on April 26 and areca trees grown in hundreds of acres were damaged. In one acre of areca farms, over 50% of areca trees were damaged. Many coconut trees were

also uprooted, causing deep distress among farmers. These trees were grown with continuous efforts of farmers all these years and have become a source of livelihood for them. This

loss has devastated many farmers, they added. The officials concerned have to conduct an actual survey immediately and sanction compensation to the farmers, they demanded.

As per national/state disaster relief fund guidelines, for crop loss at one acre of dry land is ₹8,500, irrigation land it is ₹17,000 and for perennial crop loss it is ₹22,500. This compensation could be given only if the crops were damaged more than 33%. For one hectare of areca crop loss, compensation of ₹22,500 and for one acre it is ₹9,000 will be given. Upon calculation, for one tree the government is giving just ₹16 which is unscientific. With this money, it is not able to transport the tree from the farm, they added.

Hence the Raitha Sangha has conducted padayatra demanding the increase of NDRF compensation amount. Yet the request has fallen on

deaf ears, they alleged. They demanded that the government declare the untimely rain as a natural disaster and to give compensation 20-times higher than the present NDRF mandate. All farmers who lost their crops should be given ₹50,000 per acre and the DC should conduct visits to villages that faced severe crop loss. Without bothering the farmers by seeking documents, the crop insurance should be released immediately. The loan taken by the farmers should be waived immediately and they must be given fresh loans without interest. The houses that were damaged should be given Rs 5 lakhs to construct a new house, KRRS members demanded.
