

Iran, Israel trade strikes amid mixed signals from the USA

Fresh wave of air strikes across the Iran; Israel's commercial hub hit

TEHRAN

IRAN and Israel traded strikes on Tuesday, as the West Asia war showed no sign of de-escalation after US President Donald Trump signalled "very good talks" to end the three-week conflict.

Israel's army said it had conducted a "large wave" of airstrikes across several areas of Iran, which had earlier launched a "direct hit" on a building in an upscale area of Tel Aviv.

storey building in Israel's commercial hub in ruins, as first responders scrambled to assist at least four people lightly injured at four locations.

Earlier, Iranian media reported US-Israeli warplanes had struck two gas facilities and a pipeline, hours after Trump stepped back from his threat to attack energy sites, citing negotiations to end the war.

But Tehran's parliamentary speaker, Mohammad Bagher Ghalibaf, said "no negotiations" were underway, accusing Trump of seeking "to manip-

ulate the financial and oil markets." As uncertainty swirled about diplomatic efforts to end the war, Gulf nations Bahrain, Kuwait, the United Arab Emirates and Saudi Arabia.

There are no formal diplomatic relations between Washington and Tehran, and Trump's suggestion that there had been progress in talks was met with a swift denial from Iran. But Iran's foreign ministry acknowledged that messages had been relayed by "some friendly countries" indicating a "US request for negotiations aimed at ending the war."

Pakistan PM Shehbaz Sharif said he spoke with Iran's President Masoud Pezeshkian, offering Islamabad's help for peace.

Israel set to extend south Lebanon control to Litani

BEIRUT

ISRAEL said on Tuesday that its military would take control of south Lebanon up to the Litani River, around 30 kilometres (20 miles) from the border, as deadly strikes pounded the country.

Lebanon was pulled into the West Asia war when the Tehran-backed Hezbollah militant group began fir-

ing rockets into Israel on March 2 to avenge the killing of Iran's supreme leader Ayatollah Ali Khamenei. Israel has since launched strikes across Lebanon, killing at least 1,039 people and displacing more than a million others in more than three weeks of fighting.

Israel kept up strikes across Lebanon on Tuesday, with the state-run National News Agency (NNA) reporting attacks in the country's south and east, as well as near Beirut, after a night of bombardment on the capital's southern suburbs.

Pete Hegseth first to suggest strike on Iran, says Trump

WASHINGTON

US President Donald Trump said that Secretary of War Pete Hegseth was the "first one" to suggest attacking Iran when he discussed the "problem in the West Asia" with his close aides.

Speaking at the Memphis Safe Task Force Roundtable in Tennessee, on Monday, Trump said he called all his aides, including Hegseth and Chairman of the Joint Chiefs of Staff Gen Dan Caine, to discuss the situation in Iran before making the decision.

"I called Pete, I called General Caine. I called a lot of our great people. And I said, 'Let's talk. We got a problem in the West Asia. We have a country, known as Iran, that for 47 years has been just a purveyor of terror, and they're very close to having a nuclear weapon. We can keep going and get that 50,000 up to 55 and 60, there's no end, or we can take a stop and make a little journey into the West Asia and eliminate a big problem,'" Trump said.
