

Israel and Lebanon extend truce by three weeks: Trump

US prez hopeful about historic meeting between Netanyahu and Aoun at White House

WASHINGTON

ISRAEL and Lebanon on Thursday extended a shaky ceasefire by three weeks, President Donald Trump announced Thursday, as he voiced hope for a historic three-way meeting soon and a potential peace deal.

Trump, at a standstill in negotiations with Iran, spoke in glowing terms of peace prospects for Lebanon, even as Hezbollah fired new rockets following deadly Israeli strikes.

"I think there's a very good chance of having peace. I think it should be an easy one," Trump told reporters as he met in the White House with ambassadors of the two countries, which have no diplomatic relations.

Trump announced that a ceasefire would be extended by three weeks. An initial truce was announced after the first meeting between the ambassadors on April 14 and was due to

Lebanese officials said before the meeting that they were seeking a one-month ceasefire extension. Aoun said it should include "a halt to the destruction of homes and attacks on civilians, places of worship, journalists and the medical and educational sectors."

Meanwhile, the Israeli military said its forces killed six Hezbollah fighters in a southern Lebanese town during a clash that included a firefight.

According to the military, troops identified six militants operating in the town of Bint Jbeil, an area that saw heavy fighting before a ceasefire was declared last week.

"Following the identification between the terrorists and the soldiers, during which the soldiers eliminated two terrorists," the military said.

Israel last month launched a major attack on Lebanon, killing over 2,450 people. AFP

He said that he expected Israeli Prime Minister Benjamin Netanyahu and Lebanese President Joseph Aoun to meet jointly with him at the White House during the ceasefire.

The two leaders "over the next couple of weeks will be coming here," Trump said.

Aoun earlier denied an account by Trump that he would speak by telephone with Netanyahu.

USA soldier wagered on Venezuela raid

WASHINGTON

A US Army special forces soldier involved with the capture of Venezuelan President Nicolas Maduro is due in court Friday after being charged with using classified information about the mission to win more than USD 4,00,000 in an online prediction market.

Federal prosecutors say Gannon Ken Van Dyke used his access to classified information about the operation to capture Maduro in January to win money on prediction site Polymarket.

Van Dyke, who was stationed at Fort Bragg near Fayetteville, North Carolina, was charged Thursday with unlawful use of confidential information for personal gain. A publicly listed phone number listed for Van Dyke isn't in service, and court records don't list an attorney for him yet.

Van Dyke, 38, was involved in the planning and execution of capturing Maduro for about a month, according to the New York federal prosecutor's office. He signed nondisclosure agreements promising to not divulge "any classified or sensitive information", but prosecutors say he used this information to make a series of bets related to Maduro being out of power by January 31, 2026. Netanyahu treated for early-stage prostate cancer

JERUSALEM

ISRAELI Prime Minister Benjamin Netanyahu said Friday that he has undergone treatment for prostate cancer in his first public acknowledgment of the diagnosis.

He said that roughly a year and a half ago he had prostate surgery. Then two and a half months ago, his doctors discovered and treated a small tumor at Jerusalem's Hadassah Hospital with radiation therapy. That was not publicly announced at the

time. "At my last check-up, a tiny spot of less than one centimetre in size was found in the prostate. Tests confirmed a very early-stage malignant tumour with no evidence of spread metastasis," the Israeli leader said.

"I requested to delay its publi-

cation by two months so that it would not be released at the height of the war" against Iran, the Israeli leader said, to prevent "more false propaganda against Israel." He said he was healthy and called the tumor a "minor medical issue". Agencies
