**ENVIRONMENTAL PUBLIC HEARING NOTIFICATION**

**Sri. Aldal Veerabhadra S/o Basavanagouda** has proposed to undertake Quarrying of River Sand with a production capacity of 84,460 Tonnes per Annum on a total land Area of 12.20 Acres (5.0585 Hectares) at Ordinary Sand Block-RSB-61 in Tungabhadra Riverbed Project, Adjacent to Sy. No. 11 of Chikalparvi Block-02 Village, Manvi Taluk, Raichur District. This project proposal falls under Category B1, Activity 1(a) - "Mining of Minerals" as per the Environmental Impact Assessment Notification, 2006 and its amendments.
