

USA and Iran pause attacks but differ over Doha talks

US President Trump claims Iran requested talks; Tehran denies its did so

TEHRAN

US President Donald Trump said Iran has requested a meeting that will be held in Qatar on Tuesday, despite Tehran earlier denying that any technical talks on the deal aimed at ending the West Asia war were planned.

The announcement came after Iran held its first talks with Oman on managing the Strait of Hormuz since the US-Iran deal was signed, and as Washington and Tehran agreed to halt their attacks, which had strained the agreement.

The exchanges of fire have underscored the fragility of the Pakistan-brokered agreement to stop the war, which sowed havoc across the West Asia and snarled the flow of oil and gas shipments through the vital Hormuz strait.

“Iran has requested a meeting. It will take place tomorrow in Doha!” Trump posted on his Truth Social platform on Monday, without specifying the participants. White House spokeswoman Karoline Leavitt later told Fox News that US envoy Steve

Witkoff and Trump’s adviser and son-in-law Jared Kushner “will be flying to Doha for high-level meetings this week”.

A diplomat with knowledge of the talks confirmed to AFP that officials from the US and Iran were due to meet in the Qatari capital to discuss the deal signed earlier this month.

“Technical teams working on the implementation of the MoU are scheduled to meet in Doha in the coming days,” the diplomat said on condition of anonymity. The diplomat added that “communications channels created to de-escalate any incidents

are in place” after the strikes. Qatar has played a key role alongside Pakistan in mediating a conclusion to the conflict, with the most recent discussions between Tehran and Washington taking place on June 21 with all four countries in attendance.

Iran’s foreign ministry also dismissed reports that Iranian and American technical teams would meet in the coming days to discuss implementation of the agreement. “No technical meetings of the working groups are planned for this week,” Deputy Foreign Minister Kazem Gharibabadi said, referring to the Iranian week ending on Friday. Iran’s deputy foreign minister Kazem Gharibabadi denied reports of technical talks this week, state TV reported. Nevertheless, a US official told AFP negotiations would continue despite the recent strikes. “Both sides will stand down for now and vessels can move freely” in and around the Strait of Hormuz, the official said in an email. **AFP**

Pakistani strikes kill at least 28 civilians in Afghanistan

ISLAMABAD

PAKISTANI forces’ ground operations and strikes killed at least 36 civilians in Afghanistan overnight and wounded more than 160 others, Afghan officials said Monday, as tensions between neighbors escalated. One Afghan official said the attacks would be met with retaliation.

Pakistan said the operations were launched in response to militant attacks across Pakistan. Security forces carried out a ground operation along the border late Sunday, followed by strikes against militant hideouts and safe havens, killing 29 fighters, Pakistan’s Information Minister Attaullah Tarar said.

Afghanistan condemned the strikes in Pakitia, Paktika, and Kunar provinces as a “cowardly act of aggression” and an “act of brutality.” Hayatullah Mohajer Farahi, the deputy minister for publications at the Ministry of Information and Culture, said Afghanistan would respond “in due time.”

Hamdullah Fitrat, the deputy spokesperson for Afghanistan’s Taliban government, said Pakistani forces targeted a home in Pakitia’s Chamkani district, killing an older man and a child, while other family members were wounded.

When residents gathered to rescue people, the area was struck again, killing 28 villagers and wounding 158, he said. Pakistani officials said an calm prevailed along the border, with forces on alert. **AP**
