

# 30 acres of forest land retrieved in Kudremukh

IN the past one year, the forest department has cleared 13 encroachments within the Kudremukh wildlife division and retrieved about 30 acres of land. These encroachments were identified at different points of time since 2001, and the Assistant Conservator of Forests (ACF) ordered the retrieval of the lands in 2015. After some parties appealed against the order, the final order for clearance was issued in 2019.

More than 15 cases of encroachment of forest lands are still pending to be cleared in the Kudremukh wildlife division.

Deputy Conservator of Forests (Kudremukh division) Sivaram Babu M told *TNIE* that the encroachers had planted area and coffee on most of the land, and some of them also built structures for staying there. "Mostly, they were all small households doing farming activities. In two other cases, they were running home stays, and the matter is cur-

rently sub-judice," he said.

Babu said the plantations have been removed after the eviction process, and in some places, planting of native trees will be done if necessary. "Generally, we do not take up any

# Dalit leaders raise concerns over hostel shortage, road safety

MANGALURU: Dalit leaders have alleged that despite the commencement of schools and colleges, hostel facilities have not been arranged for students, leaving those from remote areas such as Sullia, Puttur, and Beltagady, as well as other districts, facing difficulties. The issue was raised during the monthly SC/ST meeting held on Saturday, chaired by DCP Law and Order Mithun H. N. A Social Welfare Department official said that there is a shortage of hostels within the city limits and added that a proposal has been sent to the central office in Bengaluru seeking approval for two new hostels. When SP Anand asked about the possibility of arranging hostels in rented buildings, the official said the proposal would be examined. During the meeting, Girish Kumar noted that while flex hoardings have reduced in the city, they continue to be seen in the outskirts and rural areas. He also pointed out that cutouts placed in the middle of highways pose a safety risk and demanded their removal. Responding to this, DCP Ravishankar said complaints should be filed with local bodies and assured that the department would also issue letters directing their removal. SP Anand also raised concerns about street vendors encroaching footpaths in areas such as Lady Goshen Road and Car Street, causing inconvenience to pedestrians, and demanded eviction. DCP K Ravi Shankar said a letter had been sent to the Mangaluru City Corporation regarding the issue. Jinappa Bangera highlighted road safety concerns at Vamanjoor, stating that due to ongoing road widening work, pedestrians are finding it difficult to cross the road, leading to two to three accidents a week. He requested the deployment of police personnel in the area. He also alleged that late-night cricket games and illegal activities were taking place near the Vamanjoor Junction ground, adding that a youth was recently assaulted over a bike light dispute involving individuals playing cricket.
